Voltamp currently imports specialized control panels into Oman, creating a valuable opportunity for localization. With 2–3 transformer manufacturers in Oman requiring these components for production, there is strong potential for local suppliers and manufacturers to support the sector and reduce import dependency..

🌐 Market Overview

Global energy demand continues to grow rapidly, driven by population growth, industrialization, automation, and digital transformation. As countries expand and modernize their infrastructure, the need for electric grid upgrades, higher power capacities, and energy storage solutions is accelerating transformer demand worldwide.

Oman already has established panel manufacturers producing LV panels, feeder pillars, and related electrical products. Companies with existing manufacturing capabilities and infrastructure are well-positioned to expand into specialized transformer-related products and capitalize on localization opportunities within the sector.

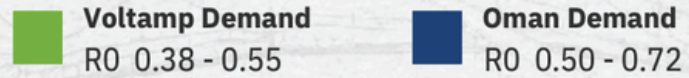
In 2025, the global transformer market is valued at approximately \$64 billion and is projected to reach \$88 billion by 2030. Rising energy consumption and the urgent need to modernize transmission and distribution infrastructure will continue to drive strong global demand for transformers and associated components.

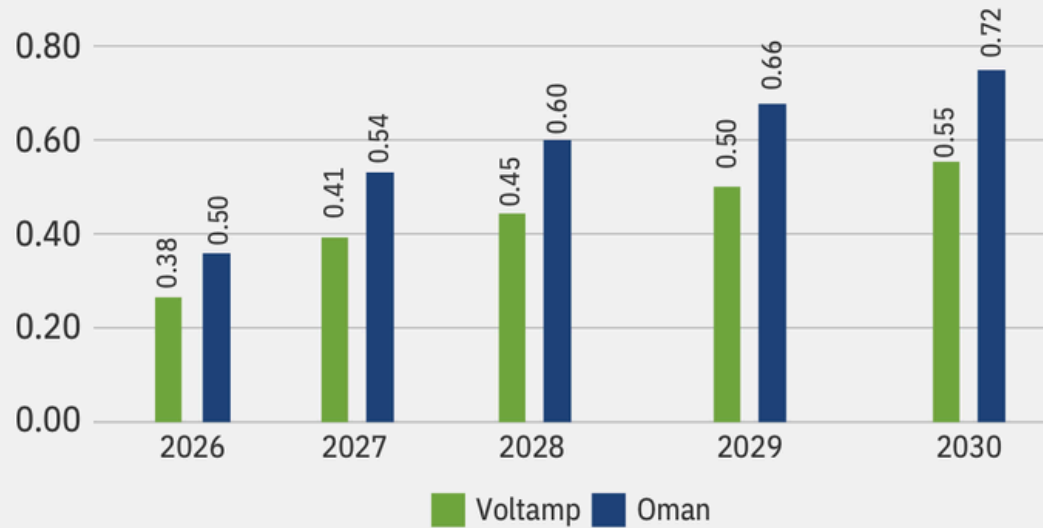


Special Transformer Panels— Demand Chart (2025-2030)

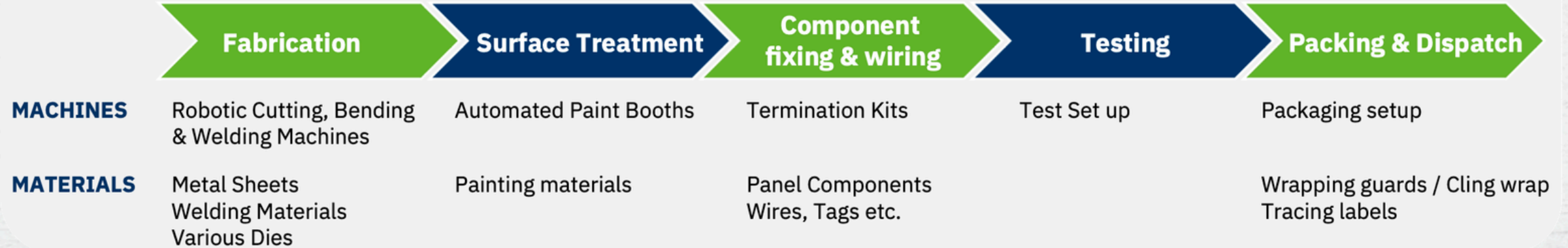
